In addition, some reshaping and cover replacement was carried out on the surface of the closed landfill and a perimeter 'apron' consisting of clay material was placed around the entire west, south and east perimeters, approx. 10 metres wide by 0.5-1 metre thick to seal cracks and mitigate any potential air ingress. Preparations are also underway regarding final cap design as part of our long term rehabilitation plan for the site.</b></p>
